Regolamenti u Proċeduri Amministrattivi dwar il-Protezzjoni tad-Data Personali

Fir-rigward tal-Proġett ta' Riċerka dwar is-Soluzzjoni tad-Data Warehouse

Ir-Regolament Ġenerali dwar il-Protezzjoni tad-Data (UE) 2016/679, (GDPR) u l-Att dwar il-Protezzjoni u l-Privatezza tad-Data Kap. 586 tal-liġijiet ta' Malta u leġislazzjoni sussidjarja relatata, jirregolaw il-ġbir u l-ipproċessar tad-data personali, dik miżmuma elettronikament, u/jew manwalment. RSIRD huwa l-Kontrollur tad-Data psewdonimizzata li sejra tiġi importata fil-Proġett dwar is-Soluzzjoni tad-Data Warehouse. RSIRD sejjer jimxi skont id-disposizzjonijiet tal- Protezzjoni tad-Data Personali kif stabbilit fl-imsemmija leġislazzjoni, kif ukoll kull leġislazzjoni sussegwenti kif ikun il-każ.

L-Għanijiet għall-ġbir tad-data:

- a) RSIRD fi ħdan MEYR, jiġbor u jipproċessa data personali psewdonimizzata tal-istudenti rreġistrati mal-Istituzzjonijiet Edukattivi tal-Istat, sabiex ikun jista' jaqdi l-funzjonijiet u l-obbligi legali mogħtija taħt l-awtorità tagħha mill-Att dwar il-Protezzjoni u l-Privatezza tad-Data Kap. 586 tal- liġijiet ta' Malta u leġislazzjoni sussidjarja relatata, primarjament, L.S. 586.07, il-GDPR u l-Att dwar l- Edukazzjoni Kap. 605, fejn applikabbli.
- b) L-iskop tal-Proġett ta' Riċerka dwar is-Soluzzjoni tad-Data Warehouse huwa li jassisti RSIRD biex janalizza għadd ta' sorsi ta' data edukattiva sabiex ikun jista' jikseb Analizi Predittiva minn tali data.
- c) Kull data miġbura għall-iskop tal-Proġett ta' Riċerka dwar is-Soluzzjoni tad-Data Warehouse se tkun psewdonimizzata u eventwalment anonimizzata malli jiskadu l-perjodi taż-żamma msemmija hawn taħt.

Riċevituri tad-data:

L-informazzjoni personali hija aċċessata mill-uffiċjali li huma assenjati li jwettqu l-funzjonijiet fl-RSIRD biex itejbu s-sistema edukattiva f'Malta. Id-data personali tista' tiġi wkoll aċċessata minn, jew hija disponibbli għall-awtoritajiet u għall-Istituzzjonijiet Governattivi waqt li qed jaqdu l-funzjonijiet



tagħhom. Id-data personali tista' tingħata anke lil terzi, li mhumiex imsemmija hawn fuq, permezz ta' kunsens mogħti b'mod espliċitu mis-suġġett tad-data jew jekk dan huwa permess bil-liġi.

Id-Drittijiet Tiegħek:

Dawn id-drittijiet tas-suġġett tad-data jistgħu jiġu ristretti, skont kif provdut fil-Legislazzjoni Nazzjonali u r-Regolament dwar il-Protezzjoni tad-Data, fejn applikabbli.

Is-suġġetti tad-data għandhom dritt jitlobu li d-data personali tagħhom tiġi emendata, jekk tirriżulta li mhix korretta, jew biex jiġi restrizzjoni tal-użu tagħha. Is-suġġetti tad-data, f' kwalunkwe żmien jistgħu jirtiraw il-kunsens mogħti u jitlobu li d-data personali tagħhom tiġi mħassra. Tali talbiet huma trattati skont il-każ. L-azzjoni biex tiġi ristretta jew imħassra d-data personali għandha tittiehed immedjatament ħlief jekk id-data personali relattiva hija meħtieġa li tinzamm u tiġi pproċessata mill-Kontrollur minħabba obbligi legali li l-Kontrollur tad-Data għandu. Fl-eventwalità fejn l-irtirar tal-kunsens u t-tħassir tad-data personali jiġi awtorizzat, dan m'għandux jaffettwa l-legalità tal-ipproċessar li diġà sar bil-kunsens li kien ingħata qabel ma' dan jiġi rtirat.

Il-GDPR tistabbilixxi proċedura formali li għandha tintuża f'każ li jsiru talbiet għal aċċess ta' informazzjoni mis-suġġetti tad-data. Kull suġġett tad-data għandu d-dritt li jaċċessa kull informazzjoni personali li RSIRD jzomm dwaru, kemm dik miżmuma elettronikament, kif ukoll dik miżmuma manwalment. It-talbiet għal aċċess ta' informazzjoni personali mingħand is-suġġetti tad-data għandhom isiru bil-miktub u jintbagħtu lill-**Uffiċjal tal-Protezzjoni tad-Data, Ministeru għall-Edukazzjoni, L-Isport, Iż-Żgħażaġġ, Ir-Riċerka u L-Innovazzjoni (MEYR)**. Mat-talba għal dan l-aċċess, għandhom jiġu sottomessi d-dettalji ta' identifikazzjoni, bħan-numru tal-karta tal-identità, l-isem, u l-kunjom. F'każ ta' xi diffikultà dwar l-identifikazzjoni tas-suġġett tad-data, wiehed jista' jintalab jipprezenta d-dokument ta' identifikazzjoni matul il-proċess intern għat-talba għal aċċess, kif ukoll qabel d-data personali tkun provduta. Dokumenti ta' identifikazzjoni għandhom dejjem ikunu pprezentati meta tingabar id-data fizikament, u meta, kif espressament jkun awtorizzat, tingabar id-data minn terz f'isem is-suġġett tad-data. Sakemm ma tkunx eżentata mil-liġi, talbiet għal aċċess ta' data personali dwar minorenni għandhom jiġu aċċettati biss jekk tiġi pprezentata prova tal-identità mill-ġenitur jew tal-kustodja legali tal-minuri.

F'każ li m'intix sodisfatt bit-tweġiba li ngħatajt għat-talba tiegħek għal access, korrezzjoni, restrizzjoni jew tħassir tal-informazzjoni personali tiegħek, jew issir taf li sar xi ksur tad-data personali tiegħek, tista' tirreferi l-ilment tiegħek lill-Kummissarju għall-Informazzjoni u l-Protezzjoni tad-Data (IDPC). Data Protection Policy

In relation to the Data Warehouse Solution Research Project

The General Data Protection Regulation (EU) 2016/697 (GDPR) and the Data Protection Act Cap. 586 of the laws of Malta and subsidiary legislation thereto, regulate the collection and processing of personal data held both electronically and, or in manual form. The RSIRD within the Ministry for Education shall be the Data Controller of pseudonymised data that shall be imported into the Data Warehouse Solution Project. The RSIRD shall comply with the Data Protection provisions as set out in the afore mentioned and any subsequent legislation as the case may be.

Reasons for Collecting Data:

- a) The RSIRD within MEYR collects and processes pseudonymised personal data of students registered with State Education Institutions, to carry out its functions and legal obligations vested in its authority by, the Data Protection Act Cap. 586 of the laws of Malta and Subsidiary Legislation thereto, primarily S.L. 586.07, the Data Protection Regulation (GDPR) and the Education Act Cap. 605 where applicable.
- b) The purpose of the Warehouse Solution Research Project is to assist RSIRD in analysing various educational data sources to be able to derive Predictive Analyses from such data.
- c) All data collected for the purposes of the Warehouse Solution Research Project shall be pseudonymised and eventually anonymised upon the lapse of the retention periods mentioned hereunder.

Recipients of Data:

Personal Information is accessed by the employees who are assigned to carry out the functions of the RSIRD to improve the education system in Malta. Personal data can be accessed by or made available to Government Authorities and Institutions in the course of their functions. Disclosure of personal information can also be made to third parties, not being the foregoing, by an expressly given consent by the data subject or as otherwise permitted at law.



Your Rights:

These rights of the data subject may be restricted, as provided in National Legislation and the Data Protection Regulation, where applicable.

All data subjects have the right to request that their personal data is amended if it results to be incorrect, or to obtain restriction of its use. Data subjects may also withdraw any consent given, at any time, and request that their personal data is erased. Such requests shall be treated on a case by case basis, and shall be immediately complied with unless the relative personal data is required to be kept and processed by the Controller in satisfaction of legal obligations the Controller is obliged to abide with. In the event where withdrawal of consent and the deletion of personal data is authorised this shall not affect the lawfulness of processing that is based on consent before its withdrawal.

You (the Data Subject) are entitled to know, free of charge, what type of information the RSIRD (the Data Controller) holds and processes about you and why, who has access to it, how it is held and kept up to date, for how long it is retained, and what the Data Controller (RSIRD) is doing to comply with data protection legislation.

The GDPR establishes a formal procedure for dealing with data subjects' access requests. All data subjects have the right of access to any personal information kept about them by the RSIRD, either in electronic form or in manual files. Requests for access to personal information by data subjects are to be made in writing and sent to, **The Data Protection Officer, Ministry for Education, Sport, Youth, Research and Innovation**. Your identification details such as identity card number, name and surname have to be submitted with the request for access. Such a request can be submitted through the following online form:

In case where certain difficulties are encountered, you may be required to present an identification document during the internal processing of the request for access and before personal data is made available. Identification documents are always to be presented when physically collecting data, and when collecting data, as expressly authorised, on behalf of the data subject. Unless otherwise exempted at law, requests for access to personal data concerning a minor shall only be accepted on material proof of parenthood or legal guardianship of the minor being presented.

The Data Controller (RSIRD) aims to comply as quickly as possible with requests for access to personal information and will ensure that it is provided within a reasonable timeframe, and in any case by not later than one month from receipt of request. Unless there is good reason for delay, when a request for access cannot be met within a reasonable time, the reason will be explained in writing to the data subject making the



request. All data subjects have the right to request that their personal data is corrected or amended if it results to be incorrect. Should there be any data breaches, the data subject shall be informed accordingly, and the incident shall be reported to the office of the IDPC within 72 hours of its being discovered.

In case you are not satisfied with the outcome of your access, correction, restriction or deletion requests, or become aware of any breach of personal data in your respect, you may lodge a complaint with the Information and Data Protection Commissioner, (IDPC) whose contact details are provided below.

Retention Policy:

Personal data shall not be retained beyond its intended requirement unless such retention is permitted by the provisions of the GDPR, the Data Protection Act Cap.586, and subsidiary legislation, and where applicable the Education Act, Cap 605 of the laws of Malta and, or as provided in any other law prevailing at the time.

The schedule hereunder specifies the retention requirements of the various categories of data to be retained by Data Controller RSIRD.

State School Student Registration data which includes attendance data, class/course data, school and household locality data, Gender and Nationality data and School Aid information	Until student turns 24 years	To analyse such information across years with the aim of being able to derive predictive statistical information that will assist the Directorate in identifying and assisting potential Early School Leavers (ESL), and also assisting Administrative Staff within the Directorate in decision and policy making.
Data indicating State School Student Stipend Grant Enrolment	Until student turns 24 years	Same as above
State School Secondary School Leaving Certificate and Profile (SSC&P) Data	Until student turns 24 years	Same as above
MATSEC O-Level Attainment Data	Until student turns 24	Same as above
State School Student Year 6 Benchmark Data	Until student turns 24 years	Same as above



Good Shephard Scheme Data of Students that start attending a State School	Until student turns 24 years	Same as above
State School Student IEP Target Likert Scale achievements	One year after student completes year 11 and is not enrolled in a state school	Same as above

Upon the lapse of the above mentioned timeframes, all pseudonymised data shall be anonymised, thereby ensuring that the data subject would no longer be identifiable.
